Official Rules

Eligibility:

Debit and Win It Sweepstakes (the "Sweepstakes") is open to Extraco Banks Discover Debit cardholders as of 08/01/2025 or other persons who are legal residents of Texas and at least eighteen (18) years old at the time of entry. Timing:

You must be an Extraco Banks Discover Debit card holder as of the start date of this Promotion for Entry Method 1 outlined below. There are two (2) methods of entry:

Entry Method 1 - Complete Transactions with your Extraco Banks Discover Debit card:

During the Promotion Period, use your Extraco Banks Discover Debit Card to complete a purchase transaction (either using the card PIN or by signing), here in "Transaction," and you will automatically receive one (1) entry into the Sweepstakes drawing (see Opt-Out process below if you don't want to be included in the Sweepstakes).
